The Warren County Board of Supervisors will hold a Public Hearing in the Warren County Government Center on Tuesday, May 15, 2018 beginning at 7:30 PM on the following items. In the event of inclement weather and the hearing is postponed, it will be held the following Tuesday.

**Virginia Department of Transportation Secondary Six-Year Plan** – VDOT and the Warren County Board of Supervisors, in accordance with Section 33.1-70.01 of the Code of Virginia, will conduct a joint public hearing at the Warren County Government Center located at 220 North Commerce Avenue in Front Royal, Virginia at 7:30 PM on May 15, 2018 to receive public comment on the proposed Secondary Six-Year Plan for Fiscal Years 2019-2024 in Warren County and on the Secondary System Construction Budget for Fiscal Year 2019. Copies of the proposed Plan and Budget may be reviewed at the Edinburg Residency Office of the Virginia Department of Transportation located at 14031 Old Valley Pike Edinburg, Virginia or at the Warren County Administrator’s Office. All projects in the Secondary Six-Year Plan eligible for federal funds will be included in the Statewide Transportation Improvement Program (STIP), which documents how Virginia will obligate federal transportation funds.
